****IF CHARGED WITH TAG, REGISTRATION, DRIVER'S LICENSE, OR INSURANCE****

If you are charged under s.320.07(3)(a), s.320.0605(1), s.322.15(1), or s.316.646(1) of the F.S. your ticket may be dismissed by providing proof of valid registration, driver license or insurance card along with a dismissal fee of \$10.00 within 30 days from the issue date of the citation. The registration, driver license or insurance MUST have been valid at the TIME the CITATION WAS ISSUED. Can not be paid online. Copy must be submitted with payment.

➔ Complete the Traffic Option Form; return with check, money order, cashier's check or credit card, (VISA or Master Card for Traffic & Criminal Payments)(Discover & American Express can also be used for Criminal Payments) There is a service fee using a credit or debit card. **Make copies for your records** before enclosing in pre-addressed envelope. **Your election is FINAL!**

➔ Mail payments to: Clerk of Court, 350 East Marion Ave, Punta Gorda, Fl. 33950, Attn. Traffic; or pay in person in Punta Gorda on the 1st Floor or @ the Murdock Office @ 18500 Murdock Circle; 4th floor. Credit Card payments are **only** accepted from **8:30 am to 11am and 2pm to 4:00pm**

➔ Hours to enroll (Punta Gorda Office Only) or make payments (Punta Gorda or Murdock) for the payment plan are **only** accepted during these HOURS: **8:30AM to 11AM & 2PM to 4PM.**
